#### Delivering better service and improved contract terms

To further enhance the service, Billmonitor introduced a dedicated support email for Town Legal, enabling prompt responses to any inquiries. Additionally, a new monthly reporting system was implemented, focusing on key usage trends and spend analysis to provide actionable insights.
